## PERMEATION. EN ISO 374-1:2016

Gloves are classified in terms of time of passage, according to each individual chemical for which the glove resists permeation:

30% HYDROGEN PEROXIDE	5	P
37% FORMALDEHYDE	3	T

## DEGRADATION

(DR) K: 40% Sodium Hydroxide = -17.83%

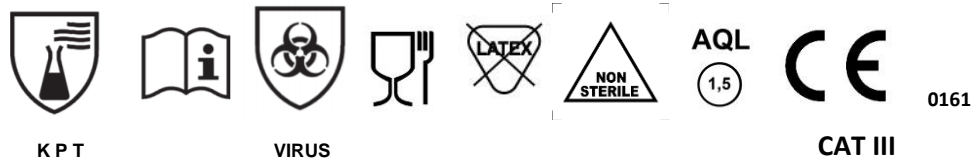
(DR) P: 30% Hydrogen Peroxide = 5.81%

(DR) T: 37% Formaldehyde = 33.75%
